Optical

We'll cover up to £300¹ per plan year if you go through any other accredited optician.



Dental

There are three key benefits.

- 1 Get up to £100 for preventative care each plan year, including check-ups and hygienists' fees.
- 2 Get up to £400¹ for treatments like fillings, crowns and dentures per plan year.
- 3 Plus, we'll cover up to £2,500 of costs resulting from a dental accident - up to two claims per plan year.

You must have had a check-up in the 15 months prior to your cover under the plan starting, and completed all recommended treatment.
